






Fig. 1 - ESD Discharge Current Wave Form acc. IEC 61000-4-2 (330  $\Omega$  / 150 pF)




Fig. 2 - 8/20 µs Peak Pulse Current Wave Form acc. IEC 61000-4-5




Fig. 3 - Typical Capacitance vs. Reverse Voltage




Fig. 4 - Typical Reverse Voltage vs. Reverse Current






Fig. 5 - Typical Peak Clamping Voltage vs. Peak Pulse Current




Fig. 6 - Typical Peak Clamping Voltage vs. Peak Pulse Current






Fig. 7 - Typical Clamping Voltage vs. Peak Pulse Current




